



Notice: THIS IS A LEGALLY BINDING CONTRACT.

In consideration of my participation in activities organised by the International Association of Bleausardes (L'association Internationale Des Bleausardes registered in France with the number W774006209, referred to below as “the Association”) including, but not limited to, rock climbing and indoor climbing, yoga, parkour and camping, as well as indoor social gatherings, workshops and lectures, I agree to the following waiver and release and I make these following representations:

I HEREBY ACKNOWLEDGE THE INHERENT EXTREME RISKS IN ROCK CLIMBING, including climbing on artificial surfaces. I realise that those risks include, but are not limited to: falls from or contact with walls or equipment, bad decision-making, inattention of spotters or actions of other climbers, misuse or failure of equipment, holds which may have become loose or damaged, and accidents which cannot be foreseen.

I acknowledge that the above list is not inclusive of all possible risks associated with the use of the facilities, and/or the sport of climbing and I agree that said list in no way limits the extent or reach of this release.

I voluntarily agree to assume all risks of personal injury, including paralysis and death, which may occur while I am participating in any event or activity organised by the Association.

I hereby knowingly and intentionally waive and release any and all claims or causes of action which might arise from my participation, and agree to indemnify, hold harmless and defend the Association, its successors, officers, employees, partners and volunteers from all liability for any such damage, injury, paralysis or death which may result.

This Waiver/Release shall be effective even though said loss, damage or injury results or has resulted from negligence, wrongful acts, omissions, breach of warranty or strict tort liability of the Association or the other parties released.

I am in good health and have not any known physical limitations, which affect my participation.

I agree to pay attention to the safety of mine and others during my participation in the events and activities organised by the Association.

Photo/Talent Release: I hereby irrevocably release, consent and authorise the Association and its agents to use my photograph/likeness/voice, as it pertains to my participation with the Association, in any manner for promotional efforts without expectation of or right to any reimbursement in connection with its use.

I am at least 18 years of age and otherwise legally competent to sign this agreement. This Waiver/Release shall be effective and binding upon me and upon my assigns, heirs, representatives, guardians and administrators.

If under the age of 18, this Waiver/Release is signed by a parent/guardian of the minor, and the undersigned waive any and all claims, and agree to indemnify and hold harmless the Association and its agents in the event of any injury to the undersigned or minor climber.

I understand that this Waiver/Release is a contract. I expressly state that I have read, understand and am familiar with all its provisions and that I sign it of my own free will.
